Company had informed the Stock Exchange that the date of payment of monthly and quarterly interest for NCD Option IV, ISIN: INE891A07029 and Option I, ISIN: INE891A07011 respectively will be 31st March, 2017.


We hereby intimate that, on perusal of offer document and prospectus of the Issue of NCDs the date of interest payment is 3rd April, 2017.

Pursuant to the particulars of the Issue and the NCDs – Working Days convention / Day count convention / effect of holidays on payment mentioned on page nos. 54 & 55 of the Prospectus of the Issue of NCDs, interest shall be calculated from the first day till the last day of every quarter and will be paid on first day of the subsequent quarter. However, if the date of payment does not fall on a Working day, then the next succeeding Working Day will be considered as the effective date for such payment of interest.

Accordingly, the interest will be calculated till 31st March, 2017 and since 1st April, 2017 and 2nd April, 2017 are not "Working Days" the payment of interest will be made on 3rd April, 2017.
