

These consolidated financial results have been prepared from consolidated financial statements, which are the responsibility of the company's management. Our responsibility is to express an opinion on these consolidated financial results based on our audit of such consolidated financial statements, which have been prepared in accordance with the recognition and measurement principles laid down in Accounting Standards mandated under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder or by the Institute of Chartered Accountants of India, as applicable and other accounting principles generally accepted in India.

We conducted our audit in accordance with the auditing standards generally accepted in India. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial results are free of material misstatement(s). An audit includes examining, on a test basis, evidence supporting the amounts disclosed as financial results. An audit also includes assessing the accounting principles used and significant estimates made by management. We believe that our audit provides a reasonable basis for our opinion.

We did not audit the financial statements of **one** US subsidiary included in the consolidated financial results, whose consolidated financial statements reflect total assets of **Rs. 32.05 crores** as at **March 31, 2016** as well as the total revenue of **Rs.6.98 crores** for the year ended **March 31, 2016**. These financial statements and other financial information have been **not** been and have been furnished to us by the Management, and our opinion on the financial results, to the extent they have been derived from such financial statements is based solely on such unaudited financial statements.

In our opinion and to the best of our information and according to the explanations given to us these consolidated financial:

- (i) include the financial results the following entities
 - a) DSK Southern Projects Pvt. Ltd.
 - b) DSK Infra Pvt. Ltd.



- c) DSK Developers Corporation (USA) and its subsidiary DSK Woods LLC
- (ii) have been presented in accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 in this regard; and
- (iii) give a true and fair view of the consolidated net profit and other financial information for the period from April 1, 2015 to March 31, 2016
